Restrictions: Open to any female born after January 1, 2014. Any female born prior to September 1, 2018 must be confirmed bred either by Ultrasound or Blood test prior to entry.

Guarantee: Any female born sold as bred must be guaranteed by the seller. It is the responsibility of the consignor and buyer to directly resolve and disputes. Sale management is not responsible for handling claims. If it is determined that a consignor or buyer acts fraudulently, they may be barred from participating in future events.

Individual DNA test results are not required for animals whose genotypes can be determined from their pedigrees and are warranted and represented as such by the consignor. Sale Sponsor assumes NO liability, legal or otherwise, expressed or implied as it relates to genomic information.

Transportation after sale: Buyer is responsible for arranging transportation of the animal after the sale. Sale management will assist buyers in making transportation arrangements but will not be responsible for providing transportation of the purchase to the new owner.
